#### DIRECTIONS FOR USE

Add a small quantity of water to a suitable compression sprayer and then add product according to the table below. Add the remainder of the water, close the sprayer securely, shake to mix contents. Pressurise according to the sprayer manufacturer's instructions. One litre of ready-for-use spray treats 20 square metres of surface. Make up spray as required. Do not store spray overnight.

Apply as a coarse low pressure spray. Several passes of a light spray each allowed to dry is more effective when treating non-porous surfaces.

Bedbugs: Apply spray to harbourages and resting places on bedframes, headboards and to cracks and crevices around or near the sleeping area.
