# ALPHAMOST PLUS

INSECTICIDE WITH ATTRACTANT. INSECTICIDE FOR PROFESSIONAL USE  
SUITABLE FOR USE IN PUBLIC HYGIENE, FOOD STORAGE PRACTICE  
AND ANIMAL HUSBANDRY.

## USES AND APPLICATIONS

For the control of flying and crawling insects e.g. Flies, Mosquitoes, Midges, Wasps, Fleas, Lice, Cockroaches, Earwigs, Silverfish and other Bristletails, Beetles, Bedbugs, Mites, Ticks, Ants, Booklice, Moths, and Stored Product Pests. For application in Domestic Situations (including kitchens); Public and Office Buildings; Hotels; Vehicles; Hospitals (excluding occupied wards); Municipal Buildings; Military use in and around barracks, Food Storage Areas, in food retailers, warehouses, raw material stores (excluding grain stores). Also can be used in animal husbandry areas such as dairies, farm outbuildings, and animal and avian housing.

## DIRECTIONS FOR USE

For space spraying apply through a hand sprayer or a fan assisted rotary atomiser as a fine mist. Spray into the air around the areas to be treated paying particular attention to sites where insects rest and breed/ harbourages. For surface spraying, apply through a suitable hand, mechanical or electric sprayer producing a coarse spray. Spray all infested areas giving special attention to cracks, crevices, dead spaces, and harbourages. Product may be applied to hard porous and non-porous surfaces. In buildings spray a maximum of 25% of wall area, ideally one wall.

For Control of Flying Insects:

For treatment of breeding and resting sites: Dilute 20 ml of ALPHAMOST PLUS with 5 litres of water, then apply over 100 square metres.

For Control of Crawling Insects:

For routine and maintenance treatment: Dilute 15 ml of ALPHAMOST PLUS with 5 litres of water, then apply over 100 square metres.

For treatment of heavy infestations, or on surfaces which are highly absorbent or dirty:

Dilute 30 ml of ALPHAMOST PLUS with 5 litres of water, then apply over 100 square metres.

## USE PRECAUTIONS

WASH ANY CONTAMINATION from skin and eyes immediately. WASH HANDS AND EXPOSED SKIN before meals and after use. Keep only in the original container. Keep container tightly closed. KEEP IN A SAFE PLACE. Keep out of the reach of children. Keep away from food, drink and animal feeding stuffs. USE ONLY AS DESCRIBED ON THE LABEL.
