Intended use: Insecticide for professional use as a crack-and-crevice treatment for the First-aid: control of crawling insects such as cockroaches, ants, fleas, bedbugs and silverfish. For use in domestic premises. (kitchens, hard porous and non-porous surfaces) and other public hygiene areas, outdoors and in food preparation and storage areas. Do not apply to bedding, clothing or soft-furnishings. Do not apply on or around drains.

Instruction of use: Shake the container a few times before using DELTASECT 015 RTU. Open the spray nozzle by setting the symbol spray and strongly press the lever. Spray on nest, hiding places and tracks of insects. Pay special attention to any slits, cracks and crevices, especially in the c.o. pipes, sewer pipes, baseboards.

For control Pharaoh ants spray wide of the path leading to the nest/sockets. On sprayed surface insecticide should form a barrier to the nest/socket. In case where tracks are not visible, the product applied to the place where insects can be found (an assembly of insects). In case of other insects, spray the place where insects sitting. In the case of re-emergence of insects, the treatment should be repeated after about two weeks.
