

APPLICATION METHOD AND RATE

Space treatment, surface spray

ULV : Dilute 1 litre of product with 9 litres of water then apply 0.5 litre of diluted product per 10,000 square metres.

Thermal fog (outdoors) : Dilute 1 litre of product with 199 litres of kerosene then apply 50 litres of diluted product per 10,000 square metres.

Thermal fog (indoors) : Dilute 1 litre of product with 399 litres of kerosene then apply 50 litres of diluted product per 10,000 square metres.

Initial spray for flying insects : Dilute 180 ml of product with 5 litres of water then apply 5 litres of diluted product per 100 square metres.

Maintenance spray for flying insects : Dilute 120 ml of product with 5 litres of water then apply 5 litres of diluted product per 100 square metres.

Initial spray for crawling insects : Dilute 180 ml of product with 4 litres of water then apply 4 litres of diluted product per 100 square metres.

Maintenance spray for crawling insects : Dilute 120 ml of product with 4 litres of water then apply 4 litres of diluted product per 100 square metres.

USES AND APPLICATION AREAS

Insecticide for professional use against flying insects such as house flies, mosquitoes, cockroaches, beetles, moths, sandflies, booklice, ants, earwigs, silverfish, bed bugs, mites, spiders, ticks, wasps and fleas in domestic and public hygiene areas including kitchens, office buildings, hotels, vehicles, hospitals (excluding occupied wards); municipal buildings; military buildings (in and around barracks); food storage areas (in food retailers, warehouses, raw material stores); on garden refuse tips and refuse tips, plus amenity areas. Also for use in and around farm buildings. Not for use in empty grain stores.
