USES AND APPLICATIONS

PERMOST 0.5% DUST POWDER can be used for the control of:

Animal Pests - such as fleas, lice, ticks, flies and red mites by treatment of animal and avian houses, bedding, blankets and rugs.

Crawling pests - such as earwigs, silverfish, bristletails, mites, fleas, ticks, beetles, cockroaches, moth larvae, ants, bedbugs, booklice, woodlice and spiders.

Wasps - by treating in and around wasp nests.

DIRECTIONS FOR USE

PERMOST 0.5 % DUST POWDER is ready to use and should not be diluted or mixed with other chemicals.

For Use in Animal Husbandry:

PERMOST 0.5 % DUST POWDER can be used in pet shops, veterinary practices, animal and avian housings, pigeon lofts etc. The product may be applied directly from the container as a fine dust over the surface to be treated. Re-treat as necessary.

For Use against Animal Pests:


PERMOST 0.5 % DUST POWDER may be used as an aid to control animal pest infestations. Apply the powder to rugs, bedding, blankets and housings used by infested animals. DO NOT apply directly to animals. The product may be applied directly from the container as a fine dust over the surface to be treated. Re-treat as necessary.

For Use against Animal Crawling Pests:

PERMOST 0.5 % DUST POWDER may be used for the control of many crawling pests. Apply the powder to the floor alongside skirting boards, and at wall/floor junctions around pipes, rubbish chutes, electrical services, or any other areas where pests are harboured. DO NOT spread randomly on the floor. Ensure powder enters all cracks, crevices, and dead spaces. Leave the powder undisturbed for as long as possible. Re-treat as necessary.

For Use against Ants and Wasp Nests:

PERMOST 0.5 % DUST POWDER may be used for the control of ants and wasps. For ant control remove the nest if possible and treat premises at all possible invasion points. For wasp control apply liberally to nest and nest entry/exit holes. Carefully treat at dusk when nest activity is reduced.
