The treatment should be carried out at times when there is reduced wasp activity e.g. dusk. Direct the jet towards the nest, beginning from a distance of about 3 metres. Spray until the nest and all visible wasps are spray until the fest and an visible wasps are contacted, and then move forward spraying continuously, until the jet can be discharged directly into the nest hole. For large nests, the whole aerosol should be discharged. Wasps are very rapidly immobilised due to the freezing action of the spray.
