

DIRECTIONS FOR USE

Add one litre of water to the spray tank then dispense the correct amount of Stingray. Add the remaining quantity of water, close the sprayer and shake and pressurise the sprayer. Apply as a coarse low pressure spray at a rate of one litre of product for each 20 sq.metres of surface. Repeat application as necessary. Wear face protection and half-mask respirator if spraying in confined places
