NOTE TO DOCTOR: Bromadiolone is an indirect anticoagulant. Phytomenadione, Vitamin K₁, is antidotal. Determine prothrombin times not less than eighteen hours after consumption. If elevated, administer Vitamin K₁ and continue until prothrombin time normalises. Continue determination of prothrombin time for two weeks after withdrawal of antidote and resume treatment if elevation occurs in that time.

The resistance status of the target population should be taken into account when considering the choice of rodenticide to be used.

DIRECTIONS FOR USE

TOMCAT 2 BLOX is a palatable, weather-resistant bait which may be used effectively in both moist and dry areas. Replace stale, damp or mouldy bait with fresh bait. Baits should be placed in situations which are protected from prevailing weather and inaccessible to non-targets (such as humans, domestic animals and wildlife). Place bait in bait stations, suitable trays or containers under cupboards, behind furniture etc, for indoor use, or in bait stations, lengths of drainpipe or beneath tiles leant against walls etc. for outdoor placement.

Where appropriate, secure the bait block at its placement site to reduce the likelihood of its removal by rodents.

RAT CONTROL: Place 2 to 10 TOMCAT 2 BLOX (usually at 5 to 10 metre intervals) per placement. Place bait in burrows and runways, along walls, or where rats are accustomed to feed. Maintain an uninterrupted supply of fresh bait for 10 days or until signs of rat activity cease.

MOUSE CONTROL: Place 1 TOMCAT 2 BLOX at 2 metre intervals per placement, where mice or their signs have been observed. Maintain an uninterrupted supply of fresh bait for 15 days or until signs of mouse activity cease.
