Flea larvae thrive environments created at the base of carpets, under ions and down the back of sofas and you should b e to treat these areas thoroughly. Hard flooring, sucl tiles, concrete or linoleum will not typically require treatment, but pay attention to any cracks and crevices which could collect debris, particularly in parquet floors and between floorboards.

Acclaim®contains S-methoprene, a long acting insect growth regulator which prevents flea eggs and larvae from maturing into adults - this breaks the life cycle and gives your home continuous protection for 12 months when used as directed. It also contains Permethrin which will kill any adult fleas which may continue to hatch in the first weeks following treatment.

Acclaim®will also kill housedust mites, ants, cockroaches, ticks, earwigs, silverfish, other bristle tails, centipedes, spiders and beetles.

Your can of Acclaim® will treat 175m² - equivalent to an entire four bedroom house. It is very important that you treat the entire house and use sufficient product. Follow the instructions carefully.

Directions for use: Remove pets and birds and cover fish aquariums before spraying. Shake the can well before use. Hold the can upside down, pointing away from your body. Using a sweeping motion, apply a fine spray uniformly to carpets, rugs, upholstered furniture and in cracks and crevices in the floor from a distance of about half a metre. Avoid wetting furniture and carpeting and do not over-apply to polished wood surfaces as spotting may occur. Leave the room and wait half an hour before airing.
